

Terms and Conditions

The following Terms and Conditions ("Terms") govern your interaction with and use of the Your DnD service ("the Service"), a web-based application managed by YourDND LLC ("us", "we", or "our").

Please review these Terms and Conditions thoroughly prior to using the Service.

By accessing the Service or using it in any capacity, you agree to be bound by these Terms. If you disagree with any part of the Terms, you should not use the Service.

1. Service Overview

The Service offers users the ability to generate Dungeons and Dragons (D&D) monsters using descriptions provided by the user. These monsters are stored on our platform. Upon registration, users receive complimentary units of Gold, and additional Gold can be purchased for further monster generation requests. Users can also create profiles, share monsters publicly in a shared catalog, and engage with other users through likes, following, favoriting, and commenting. Content shared on the platform is available to the internet at large.

2. Gold

Gold serves as a digital currency within the Your DnD platform, primarily for generating monsters. Gold has no monetary value, is non-refundable, non-exchangeable, and is not intended as real or virtual currency under any law. Gold is available for purchase via Stripe Checkout, with terms and prices subject to change without notice.

3. User Content

Users are solely responsible for the descriptions they provide and the content they post, including any public sharing in the shared catalog. You affirm that you own or have the necessary licenses, rights, consents, and permissions to publish the content you submit. We reserve the right to remove any content deemed inappropriate or offensive.

By posting content to the Service, you grant us a non-exclusive, worldwide, royalty-free, sublicensable, and transferable license to use, reproduce, distribute,

prepare derivative works of, display, and perform the content in connection with the Service and YourDND LLC's (and its successors' and affiliates') business, including without limitation for promoting and redistributing part or all of the Service (and derivative works thereof) in any media formats and through any media channels.

4. User Accounts

You are responsible for safeguarding your password and for any activities under your account. You must not disclose your password to any third party and should notify us immediately upon any breach of security or unauthorized use of your account.

5. Intellectual Property
